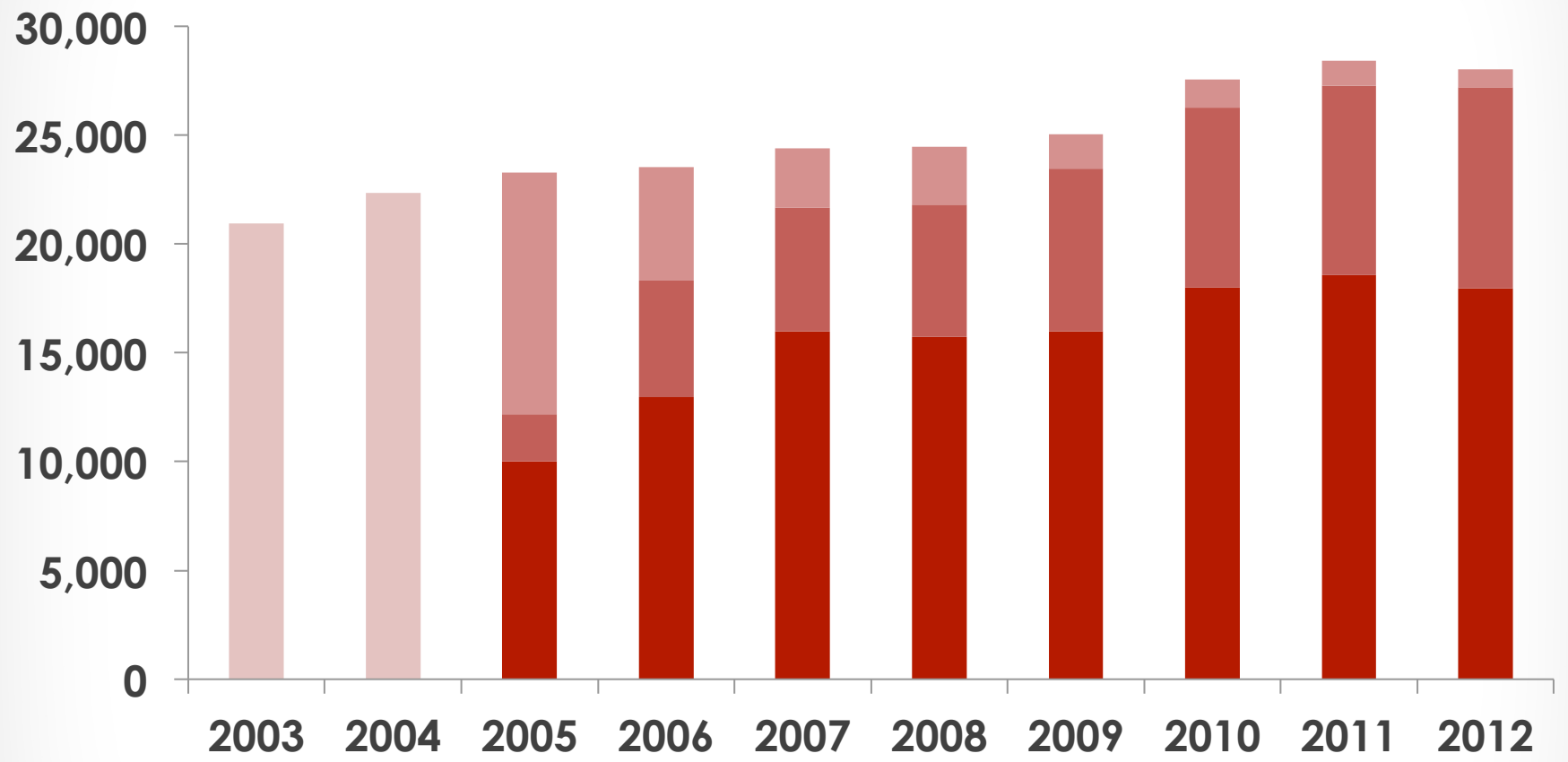

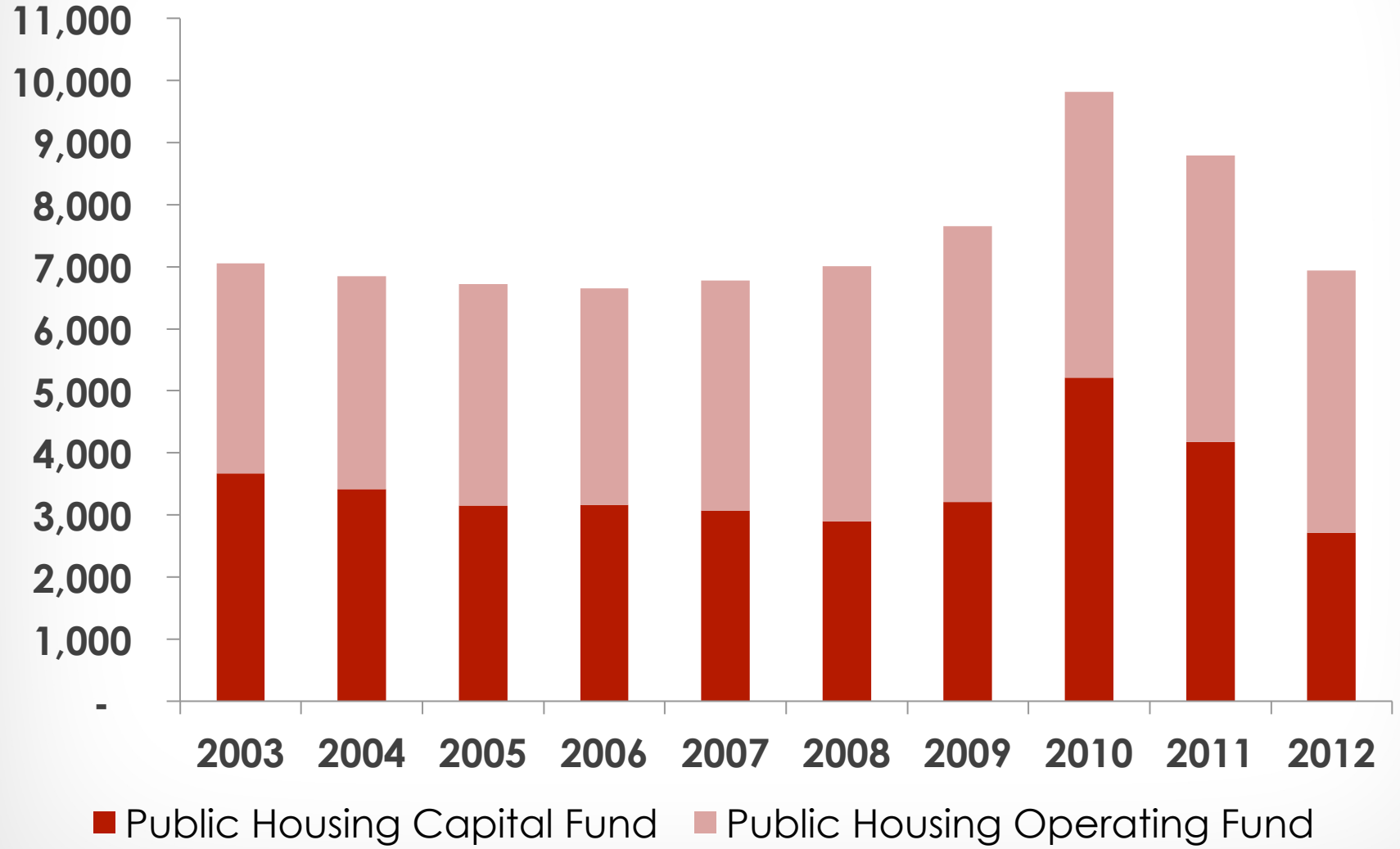

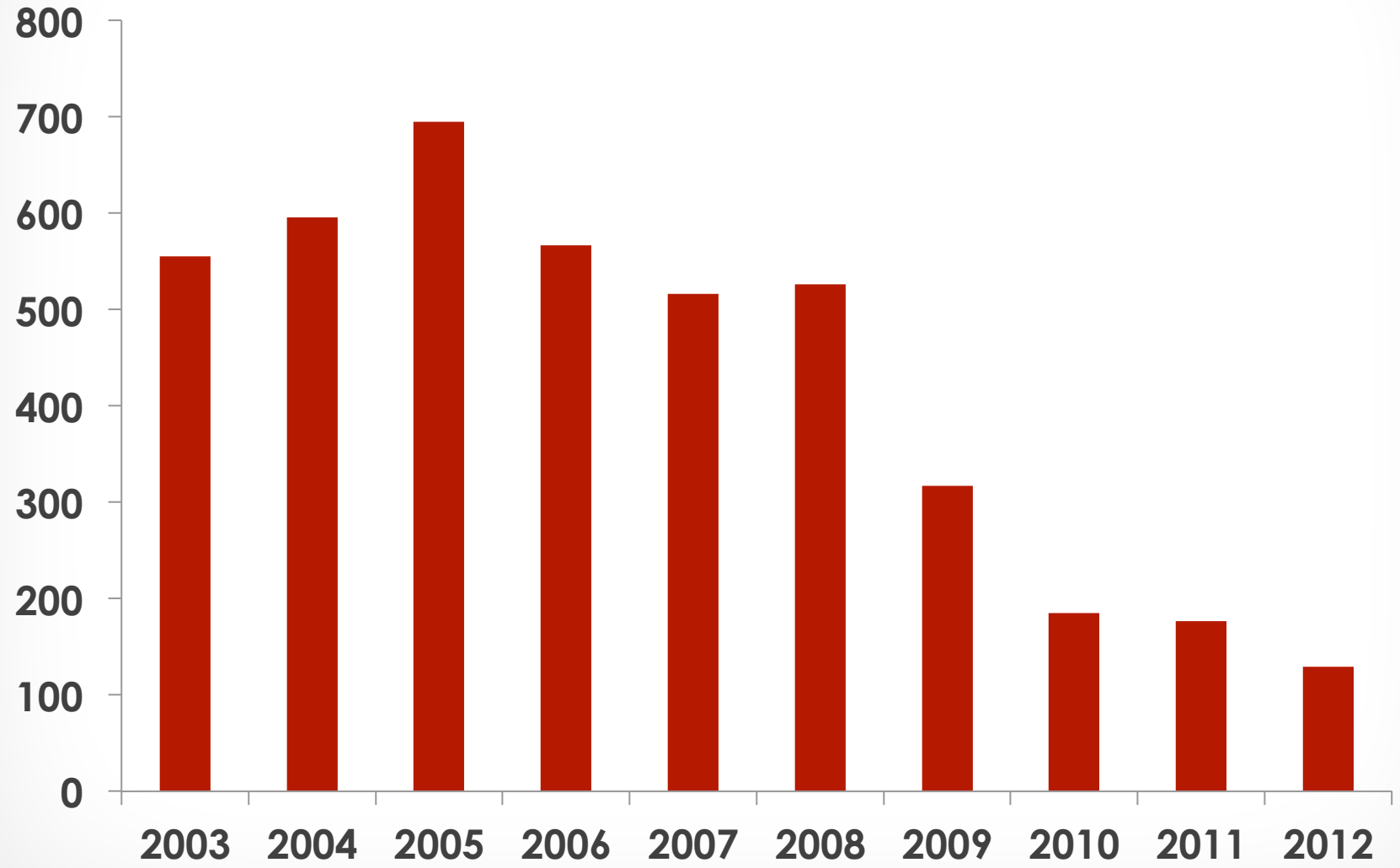

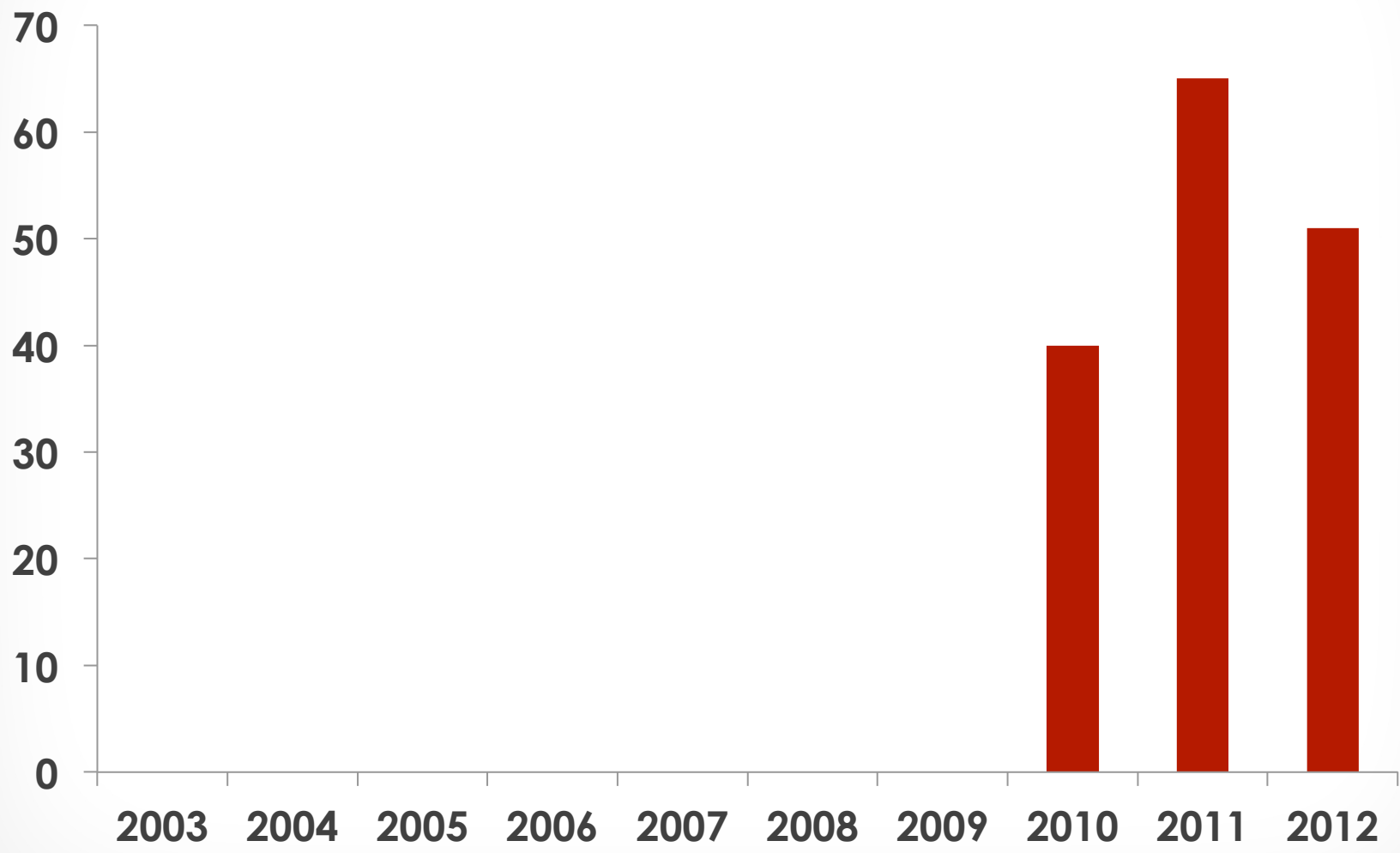

Outlays in millions of dollars

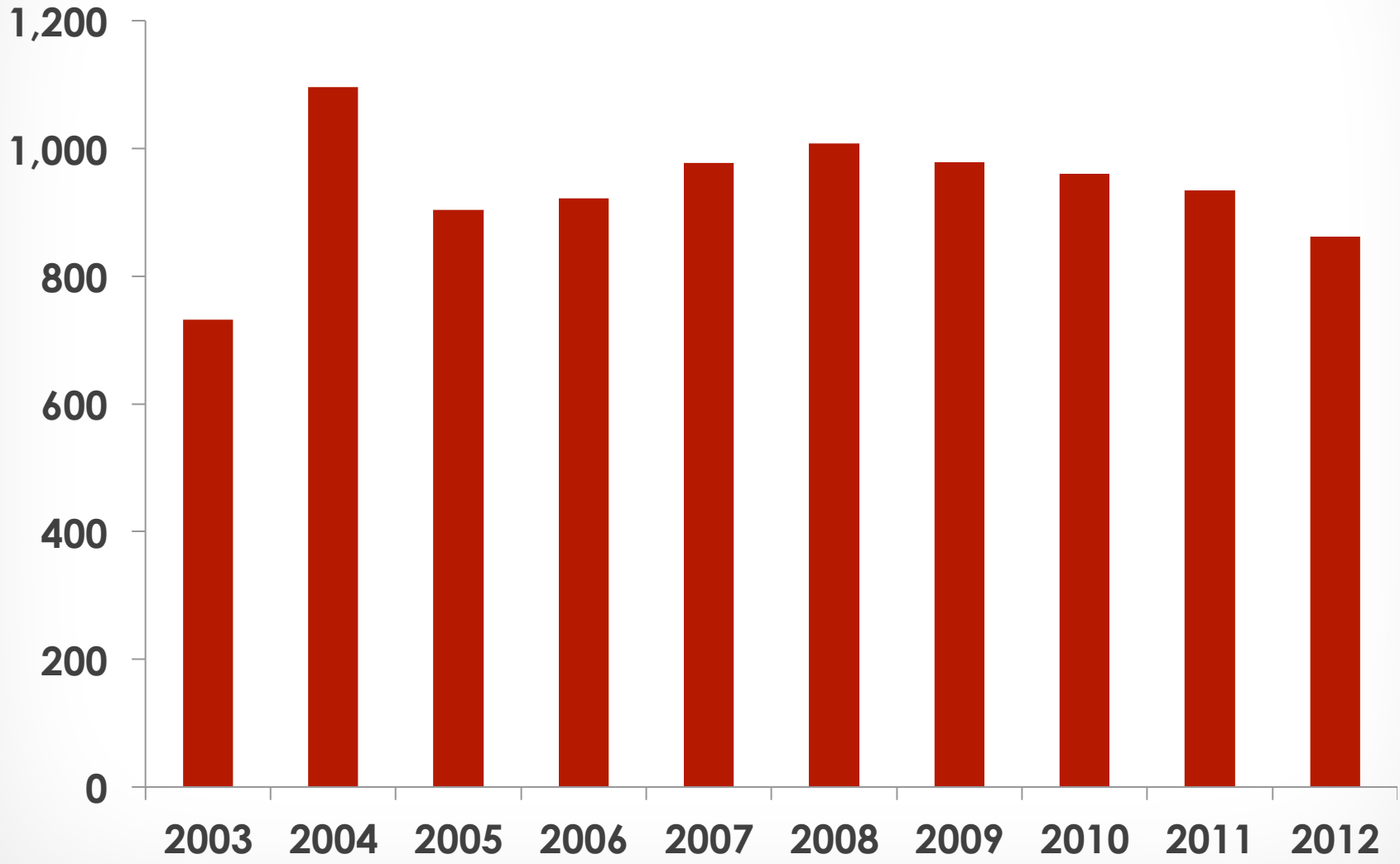

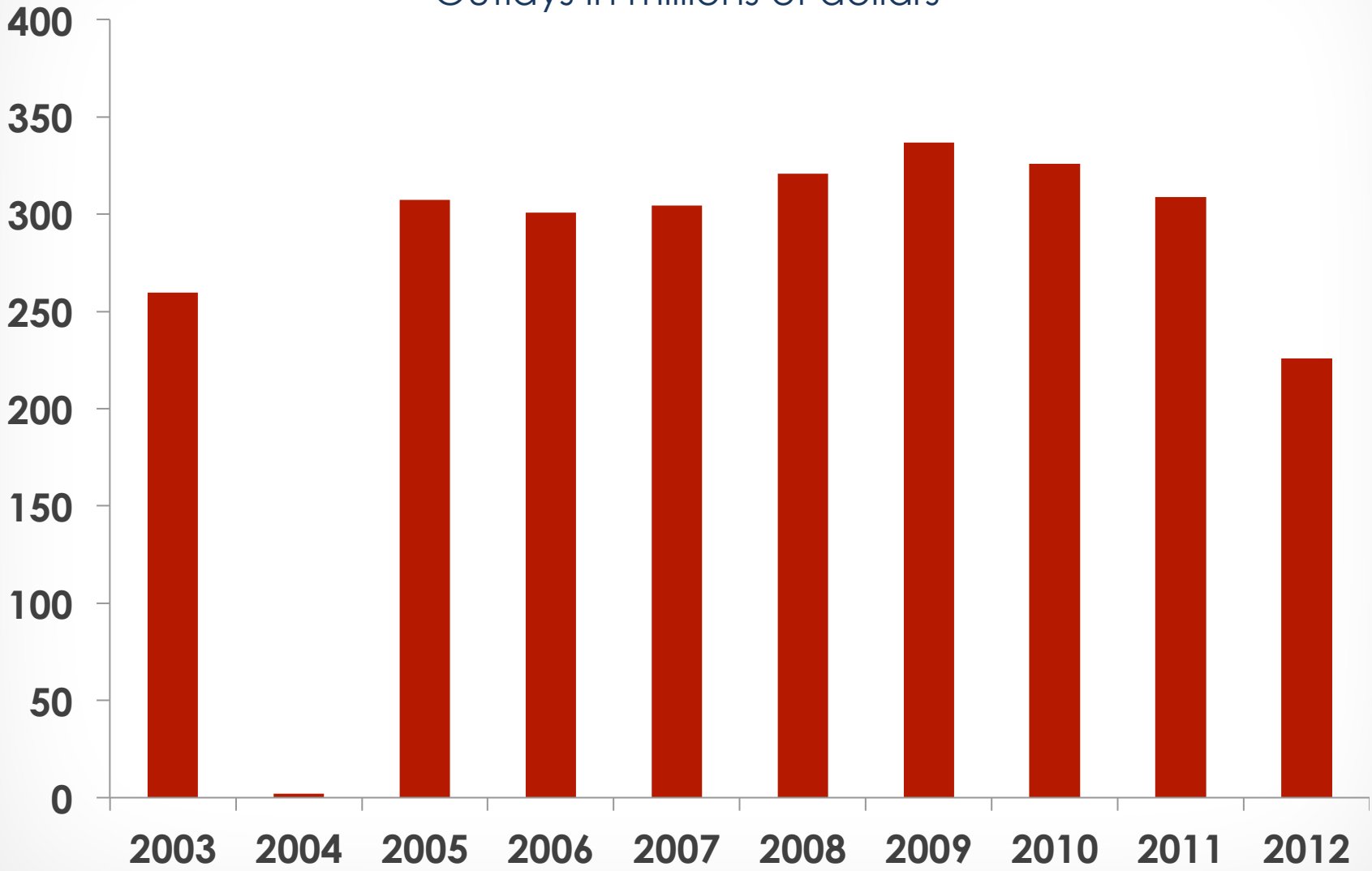

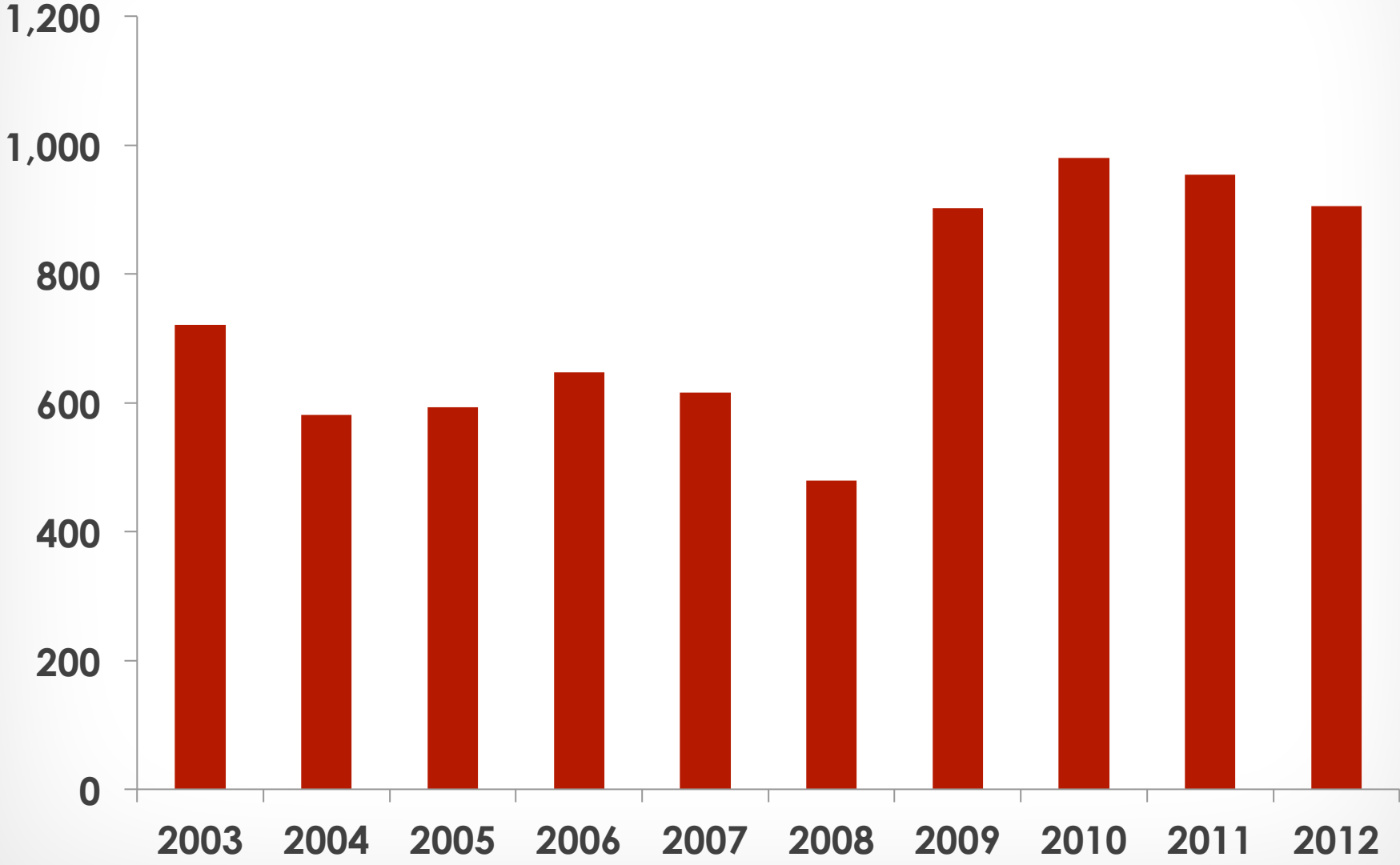

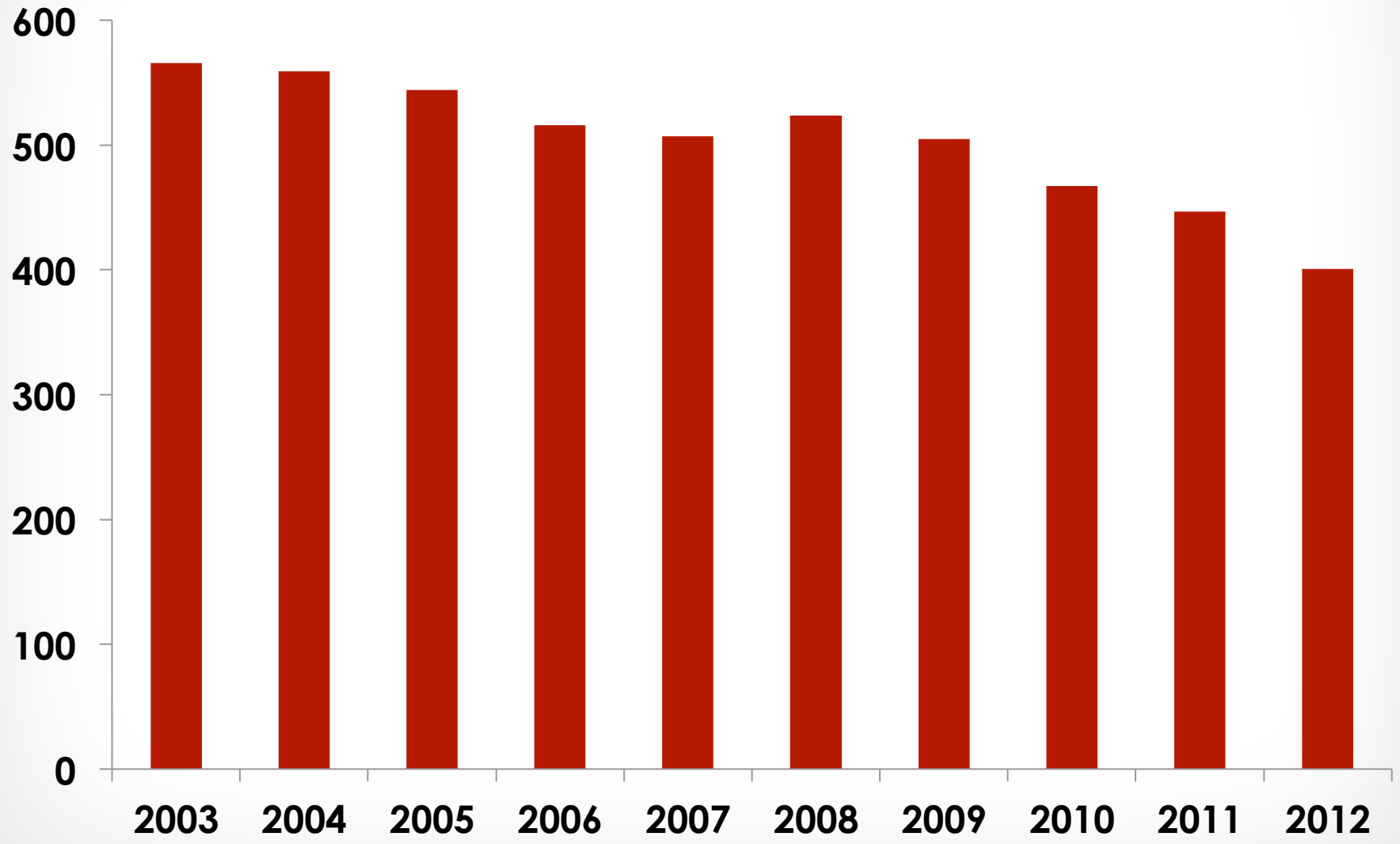

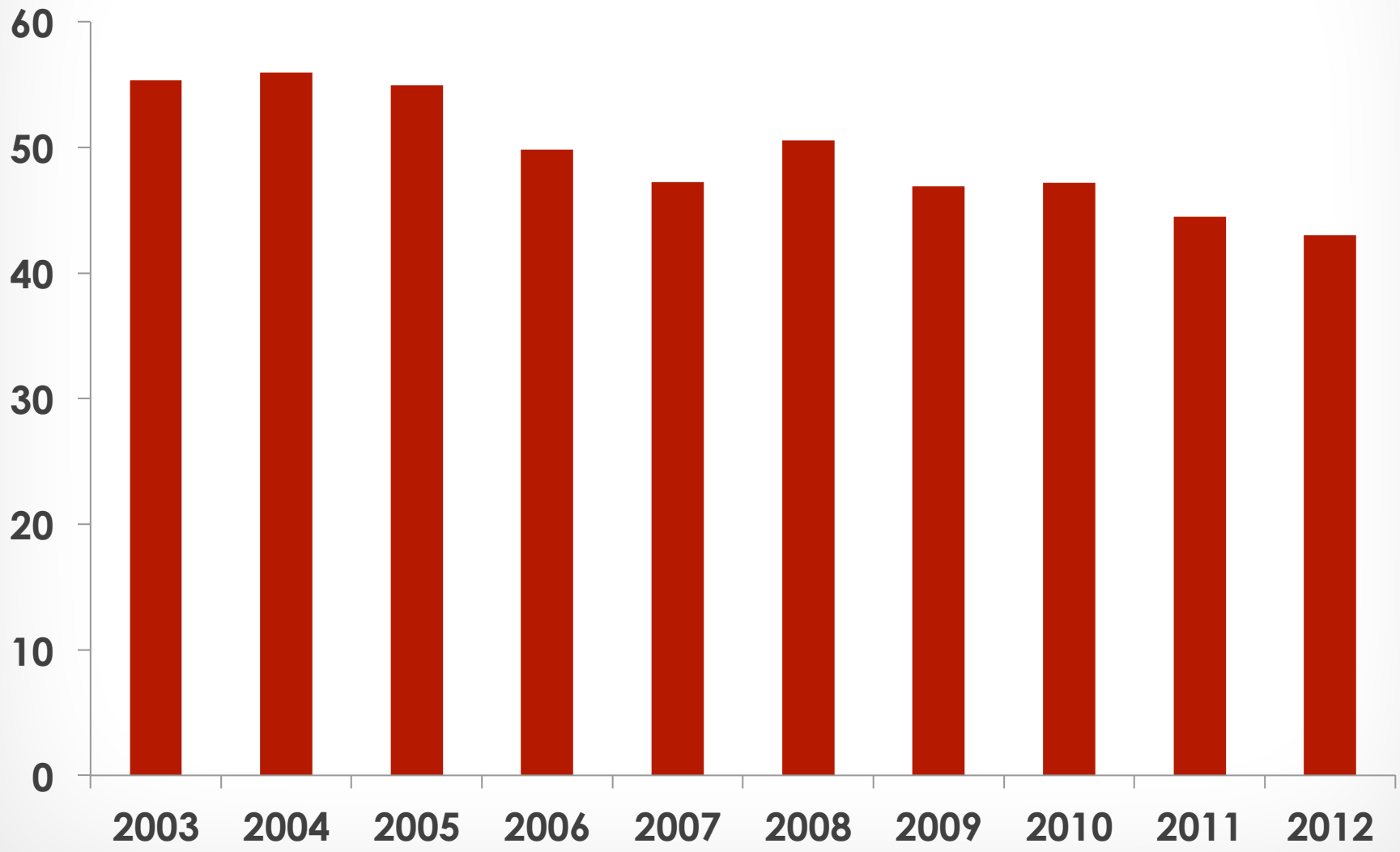

RENT SUPPLEMENT PROGRAM FUNDING

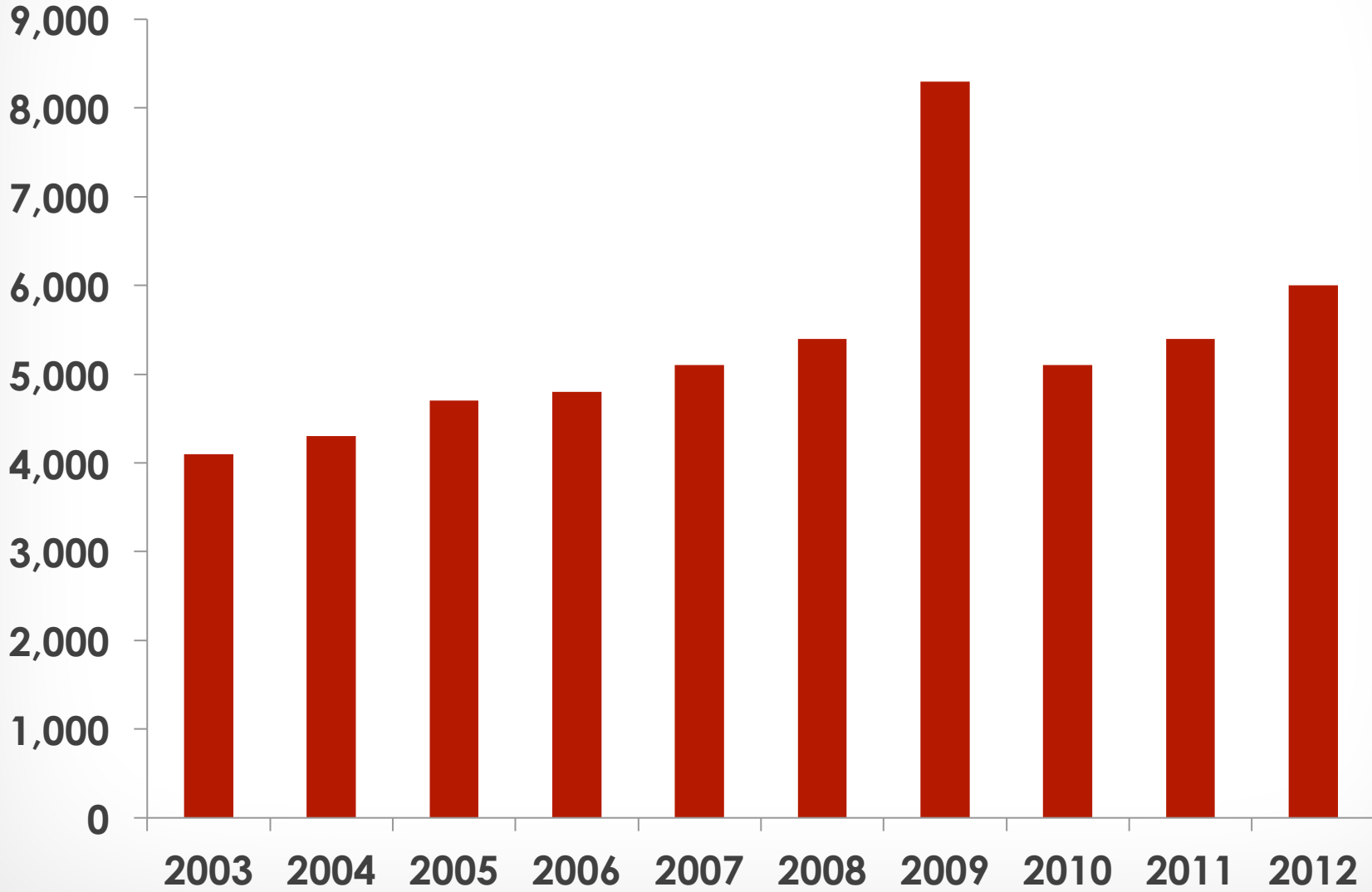

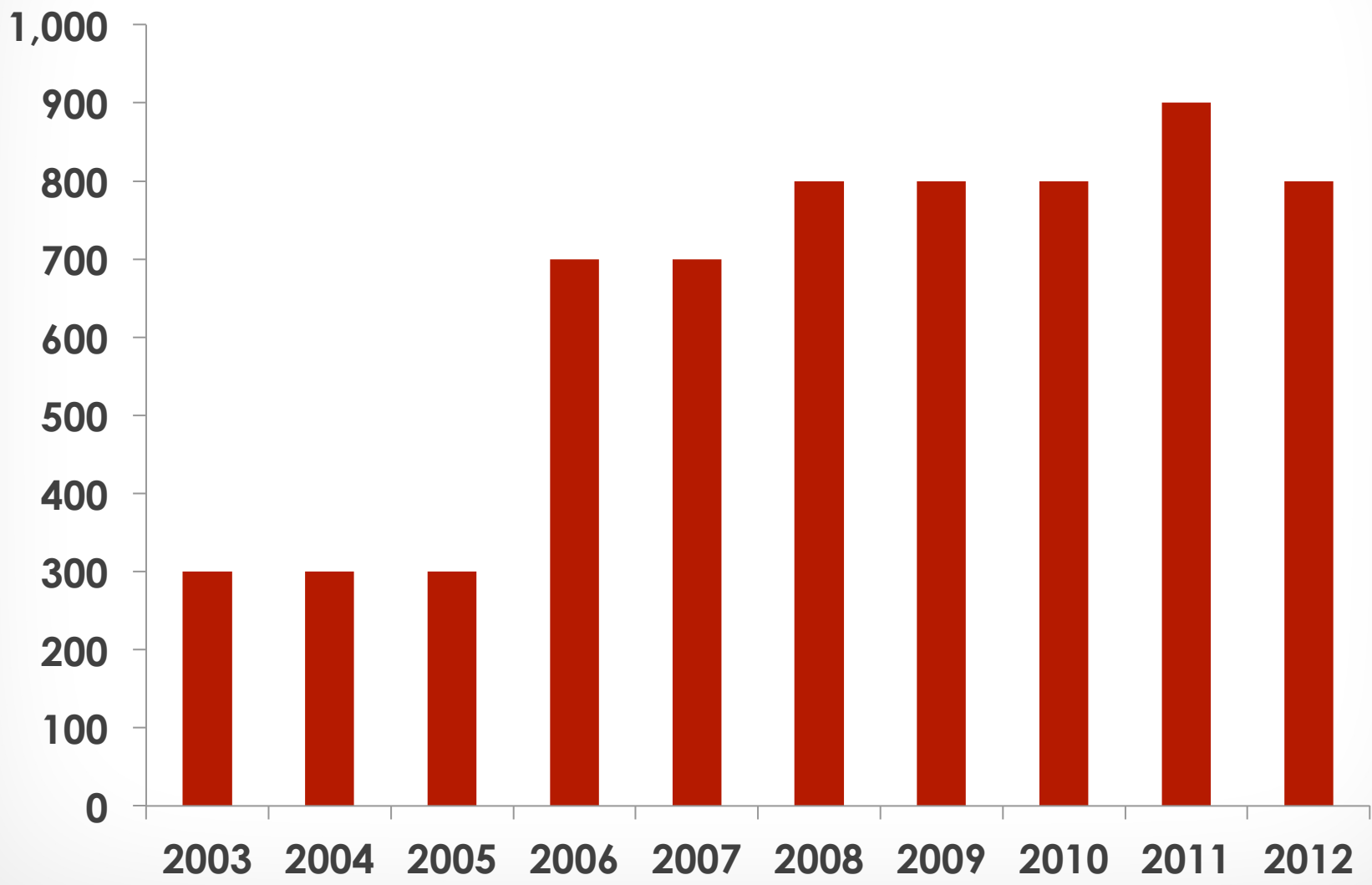

PAB INTEREST EXCLUSION FOR THE DEVELOPMENT OF RENTAL HOUSING

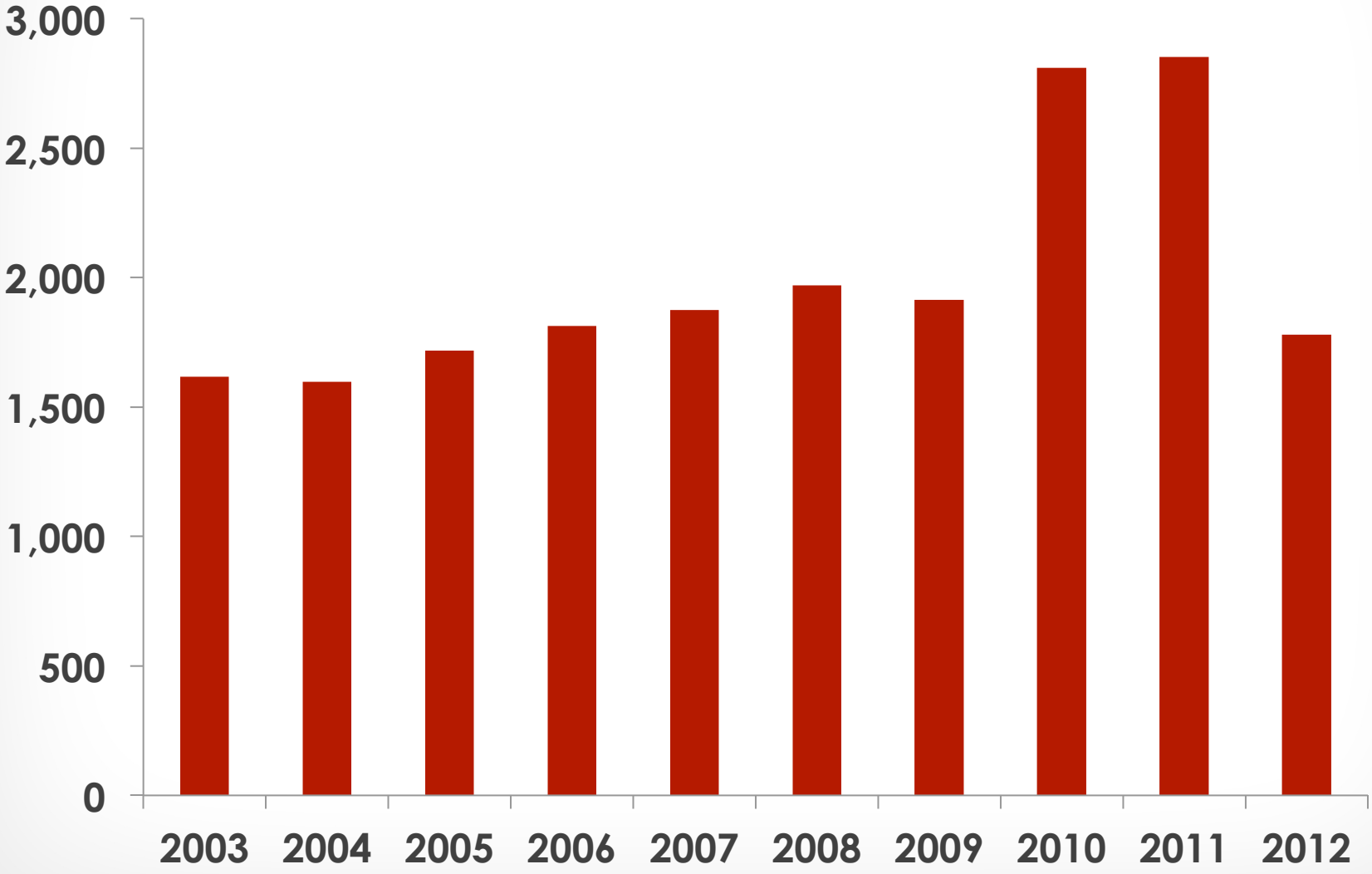

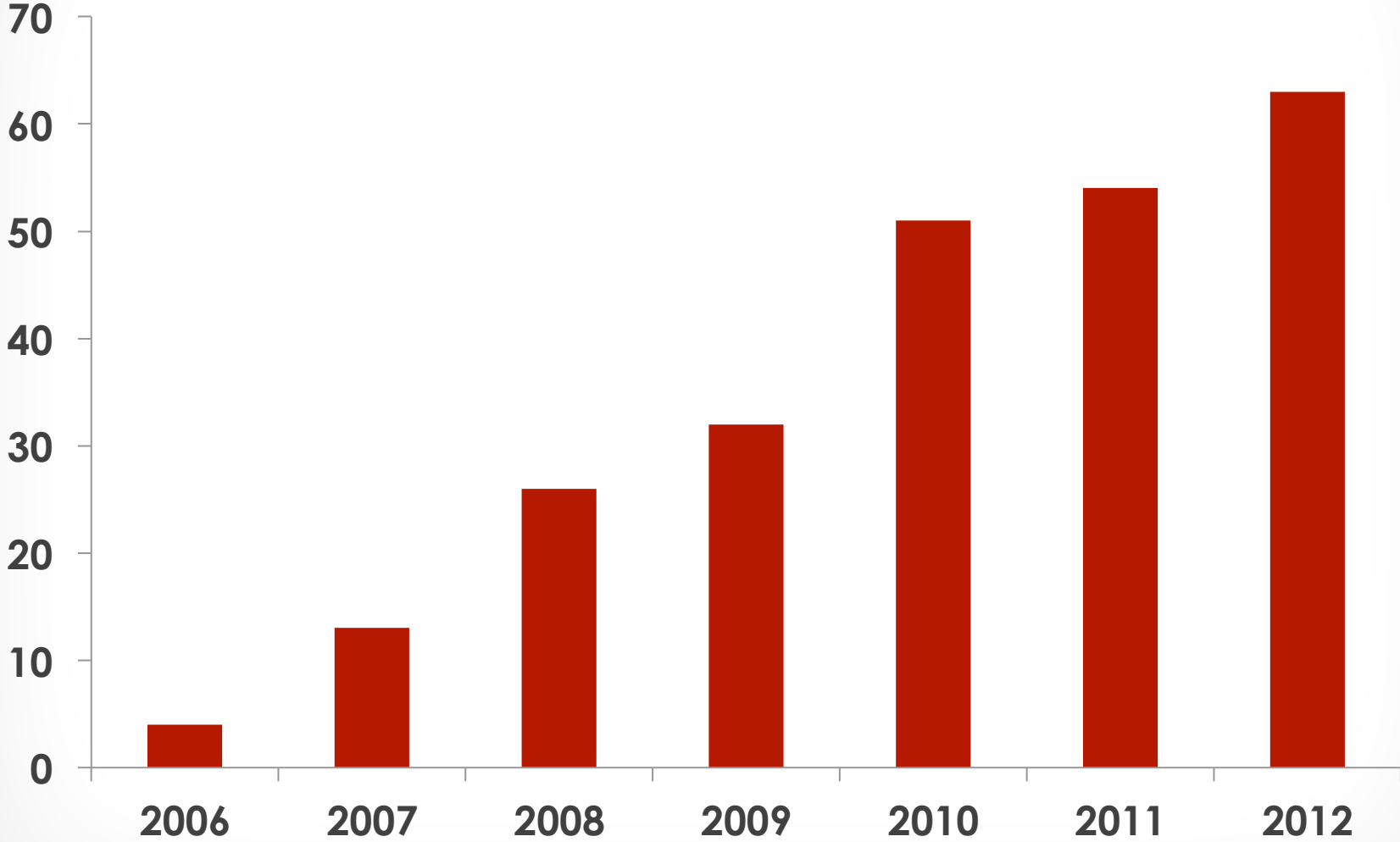

Outlays in millions of dollars

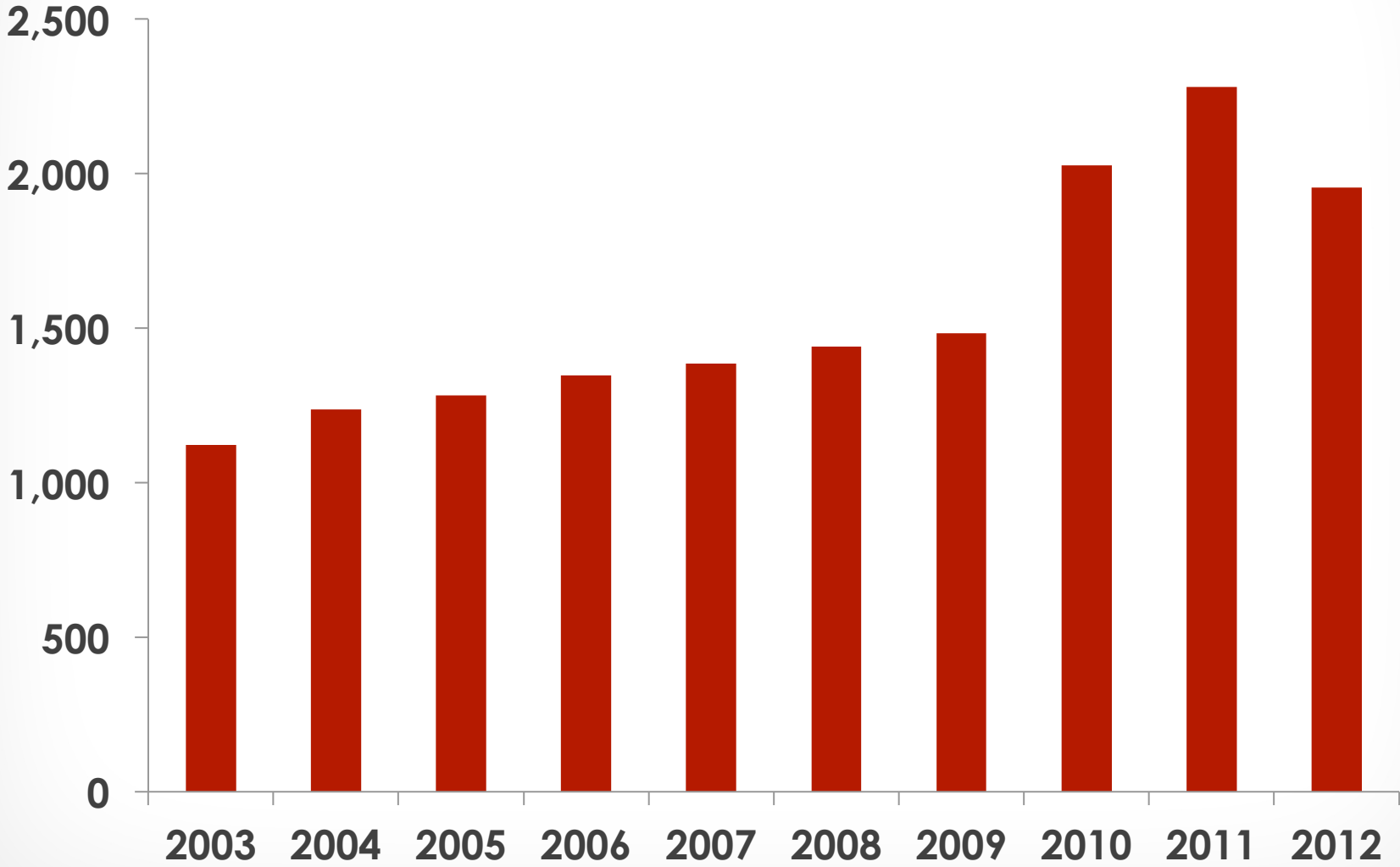

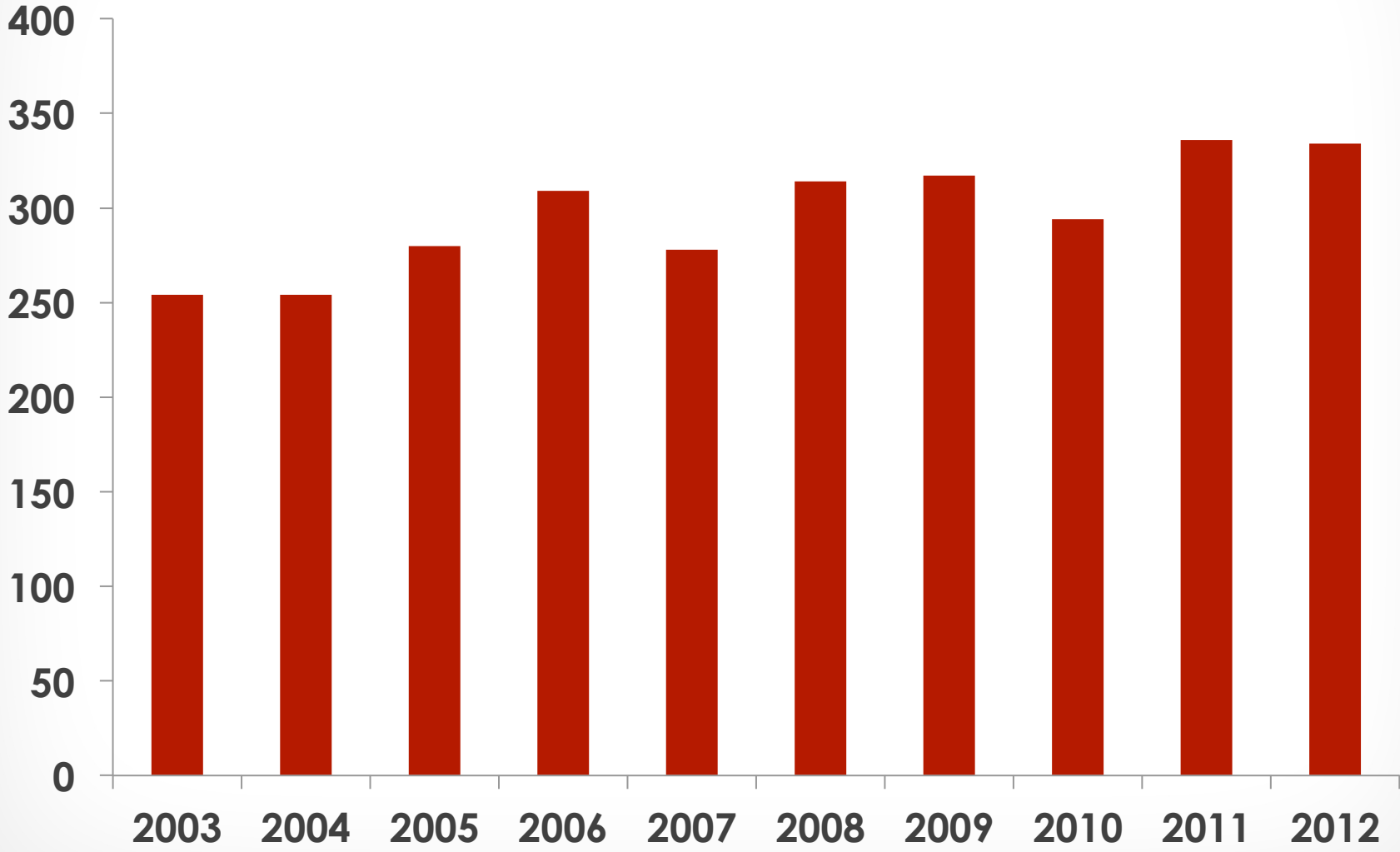

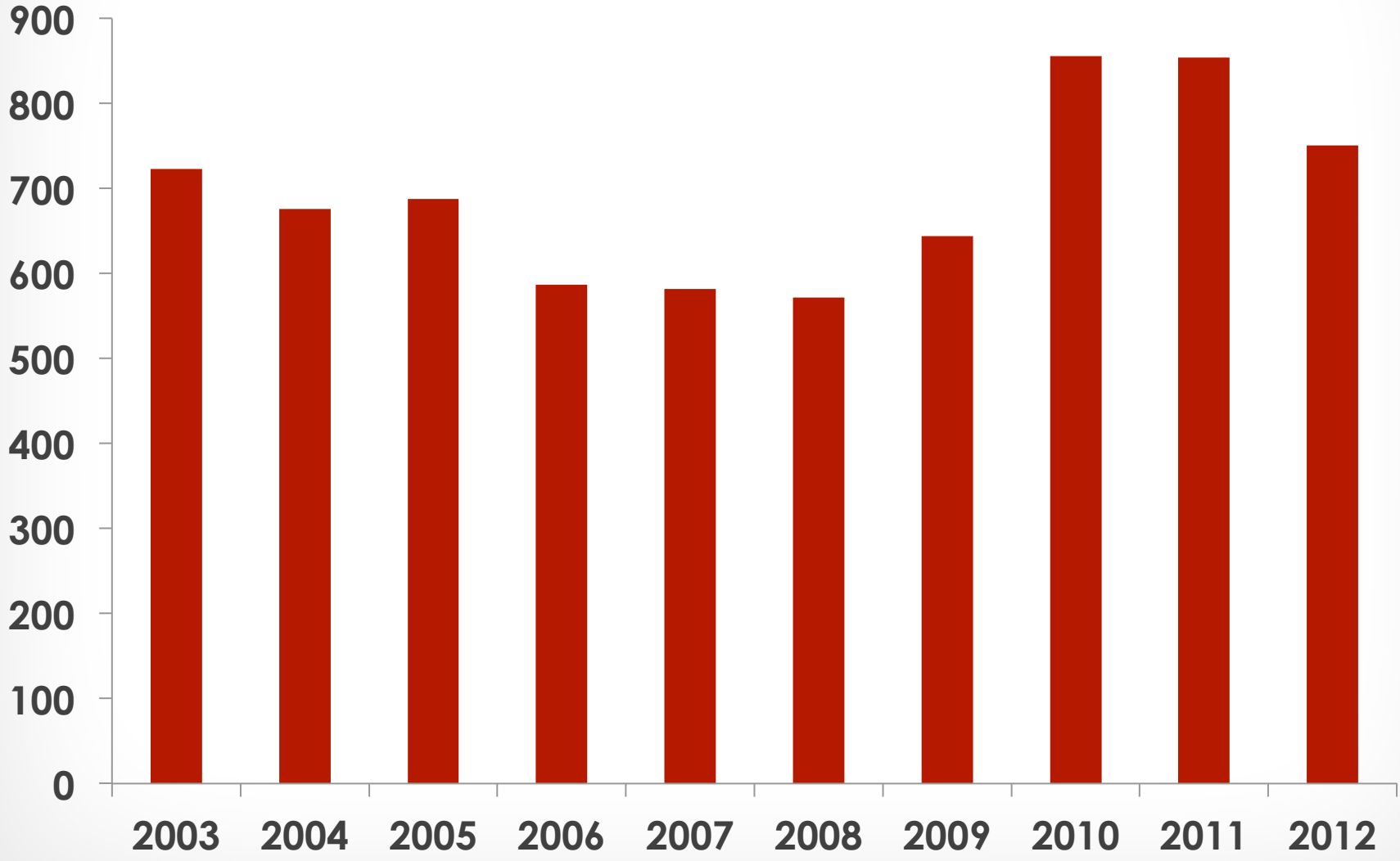

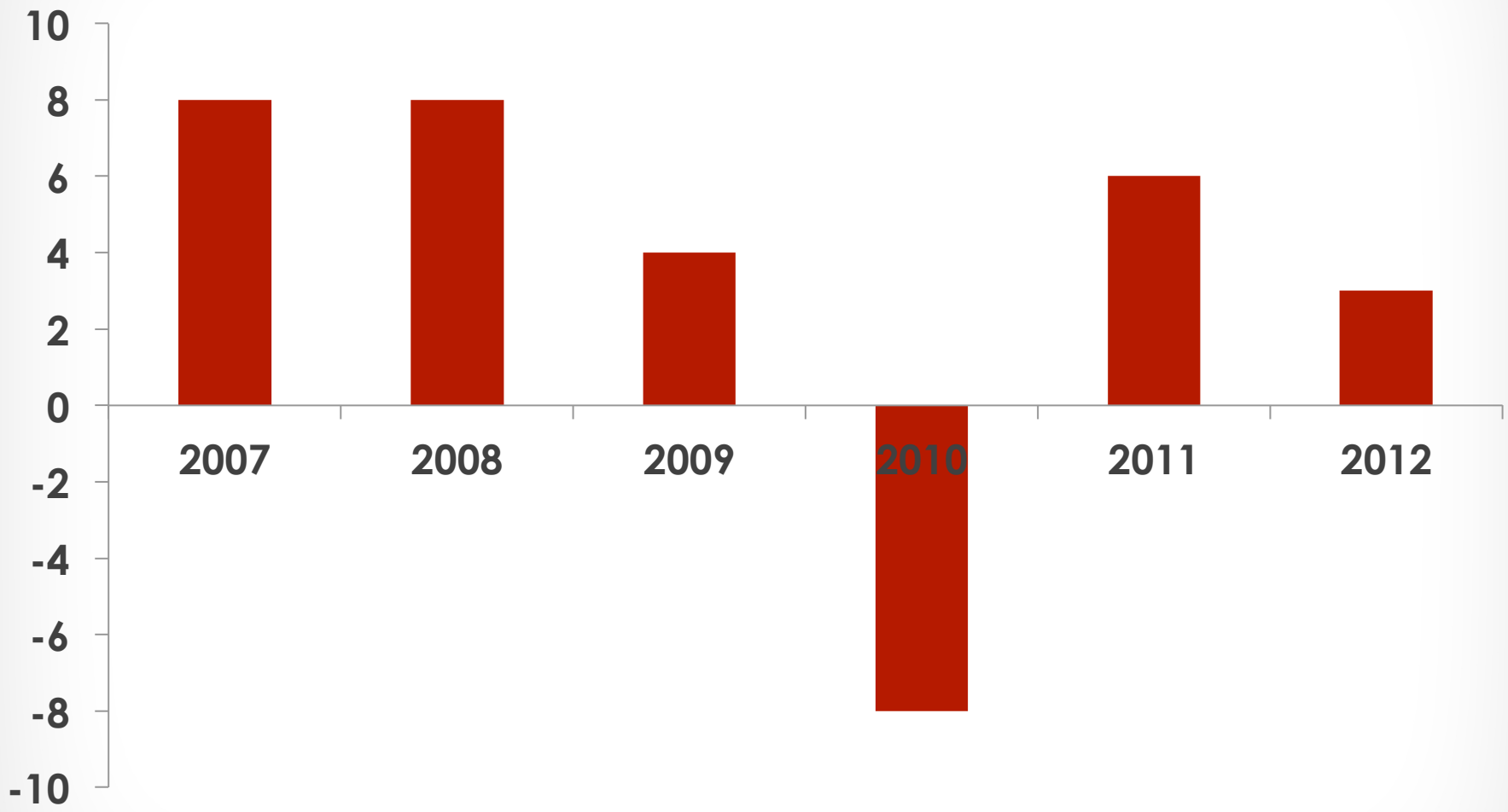

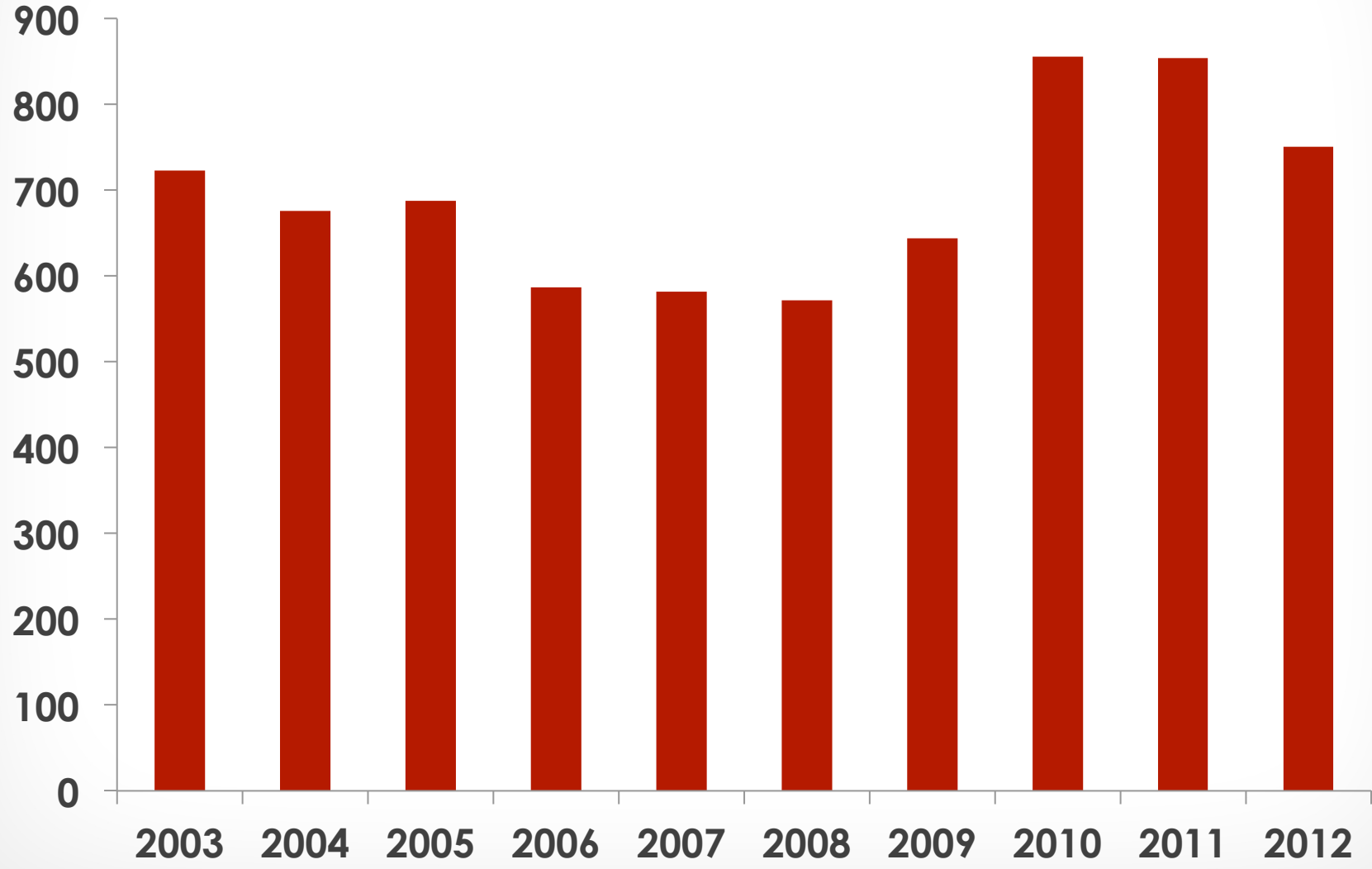

AFFORDABLE HOUSING PROGRAM FUNDING

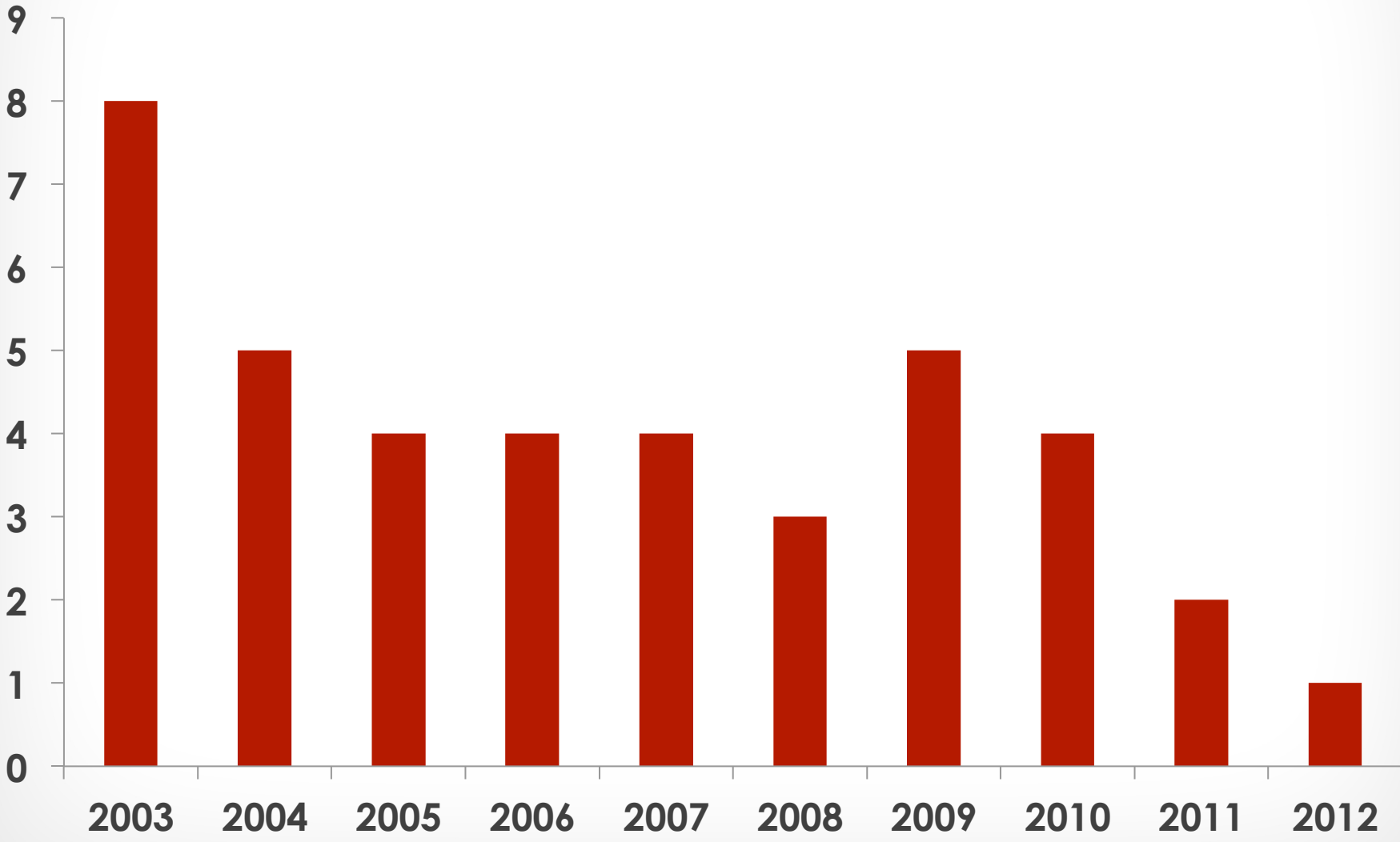

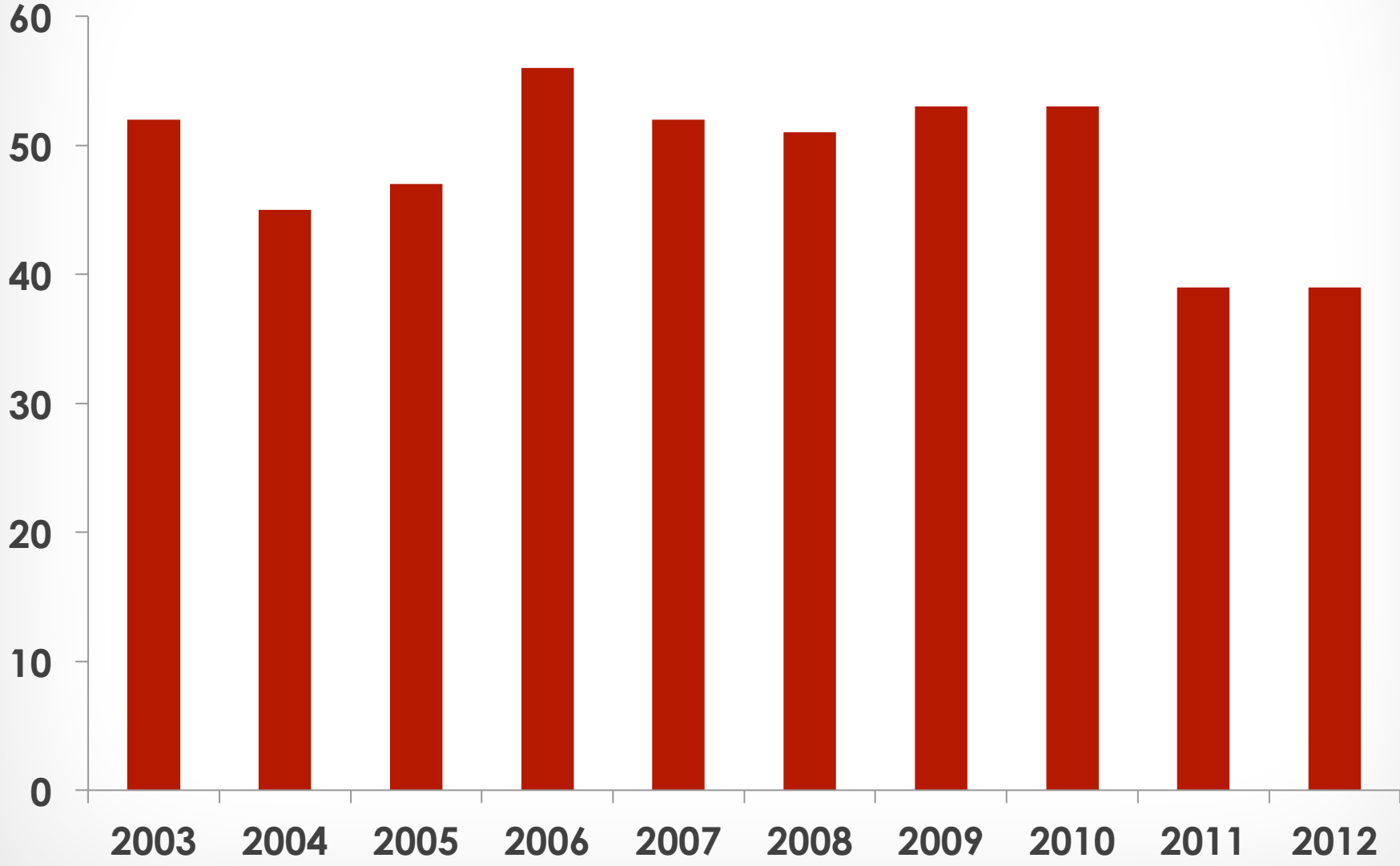
