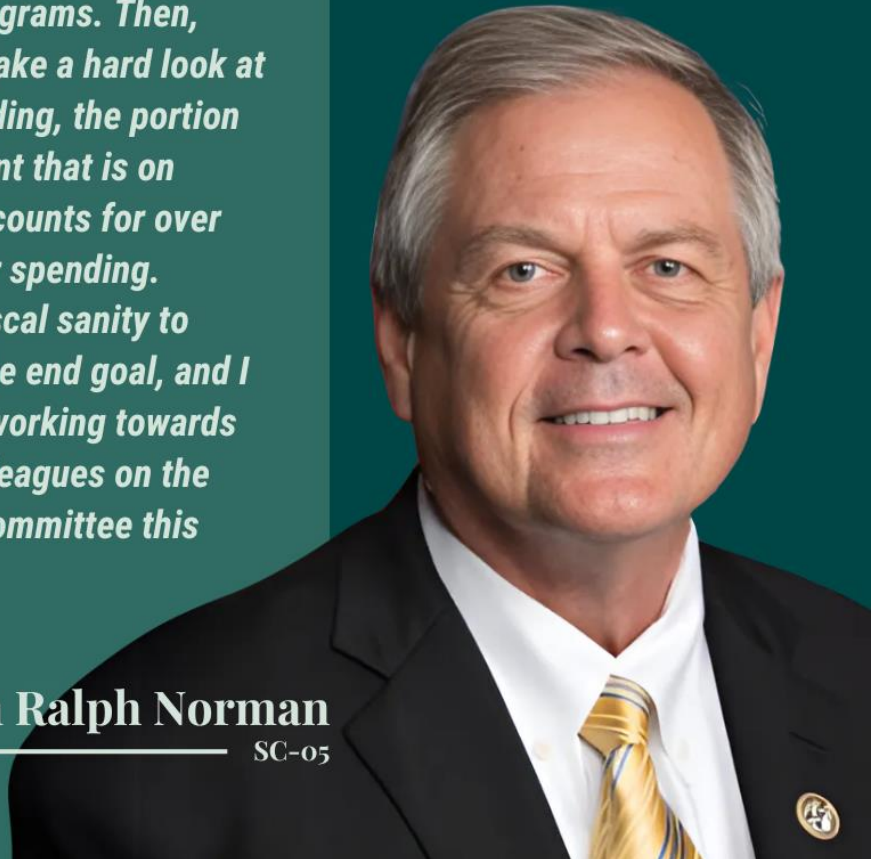


REP. RALPH NORMAN (SC-05) STATEMENT

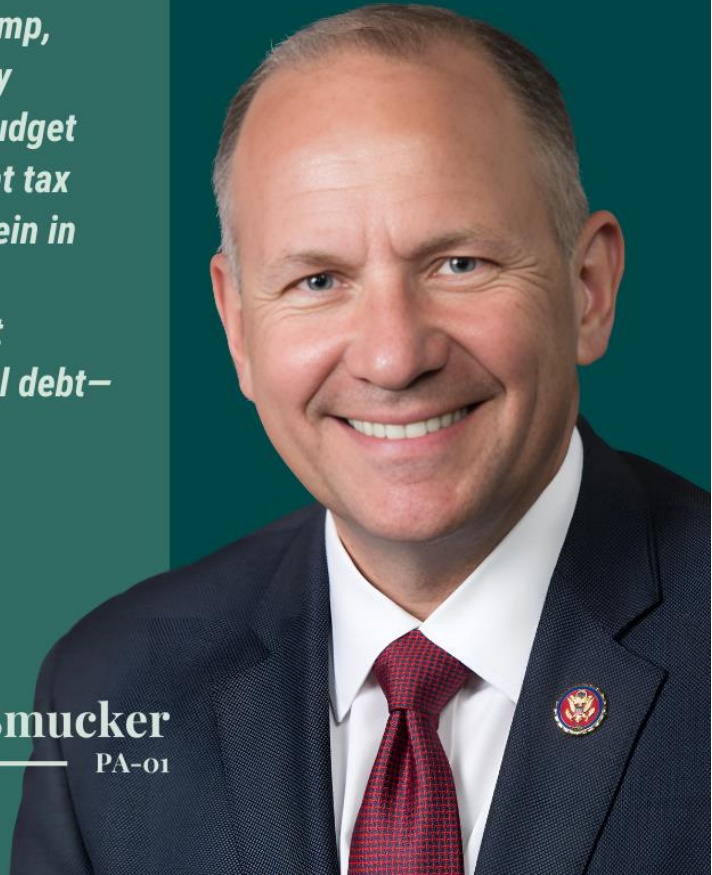

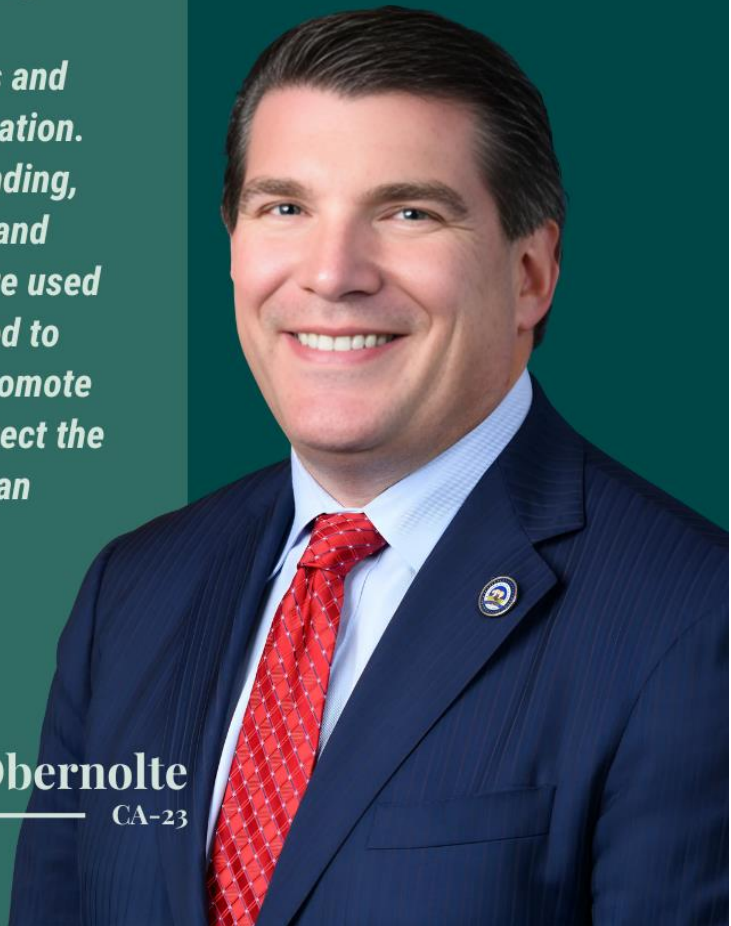

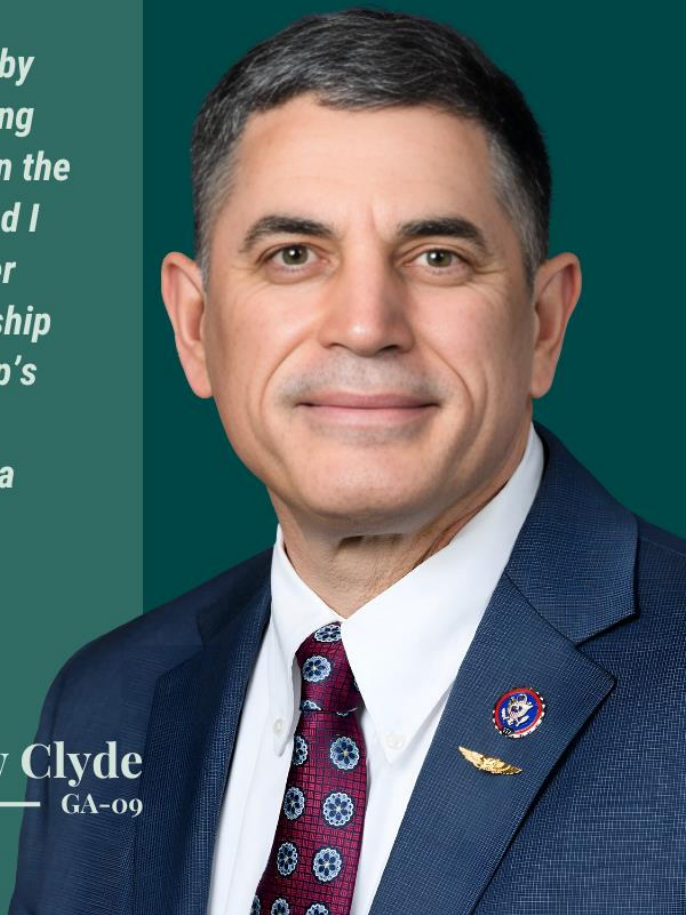
