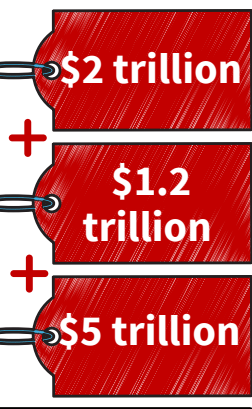


BUDGET BALANCE SHEET: 1 YEAR OF TOTAL DEMOCRAT CONTROL

RECORD SPENDING, TAXES, AND DEBT:



Biden Bailout Bill — less than 9% went to fighting COVID-19.

Infrastructure bill — \$625 billion in new spending with a \$400 billion shortfall in offsets.

Reckless spending bill — largest in U.S. history, confirmed by CBO to cost 3x what Democrats claim and packed full of budget gimmicks.

\$7.5 TRILLION in new spending.

&

\$1.5 TRILLION in new taxes — the largest tax increase proposal in U.S. history.

TWO-THIRDS of employer tax increases will fall on low/middle-income Americans.

\$80 BILLION for the IRS to double the number of agents and target bank accounts of 87 million Americans earning under \$400,000, according to JCT.

THE FY22 BIDEN/BERNIE BUDGET:

- 73% increase in annual government spending for the next ten years, compared to the previous decade.
- \$68 trillion in spending — when combined with all spending since 2019 under House Democrat Majority it would be more than total taxes paid by all Americans in history.
- \$17 trillion in new debt — greater than GDP of every country on earth, except the U.S.

HIGHEST SPIKE IN PRICES IN 40 YEARS:

The cost of goods is up over 7% since President Biden took office, the highest since Carter-era policies. The Biden Administration's Office of Management and Budget (OMB) predicted approximately 2% inflation.

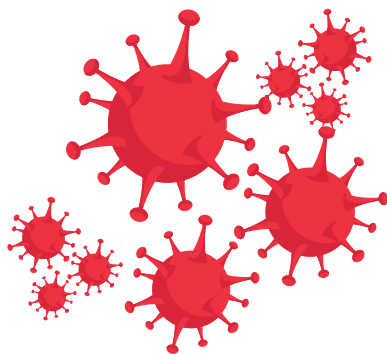

DEMOCRATS' MISPLACED PRIORITIES:

- ✗ Less than 9% of the \$2 trillion Biden Bailout Bill went to combating COVID, while \$500+ billion went to state and local governments — rewarding lockdowns.
- ✗ \$400 billion of the \$2 trillion Biden Bailout Bill went to policies that reduce private-sector employment.
- ✗ Defunded construction of the border wall — making America less secure.
- ✗ Dishonest about the costs to house, transport, and service the massive surge of illegal immigrants.
- ✗ The FY22 Biden/Bernie Budget provided a ZERO percent increase in Homeland Security funding — flatlining border security efforts — while averaging a 16% spending increase for non-national security agencies.

Refused to commit to not using American taxpayer dollars for viral research in China.



Rushed Biden's vaccine mandate rule through OMB's rulemaking department that is absent any nominated or confirmed head.

RECKLESS \$5 TRILLION TAX & SPENDING RECONCILIATION PLAN:

- ✗ 150+ new government programs.
- ✗ \$330 billion in new incentives for people to stay home rather than work.
- ✗ \$550 billion for the Green New Deal.
- ✗ Taxpayer-funded subsidies for the wealthy including homebuying, EVs, child care, pre-K, paid leave, Obamacare, and more.
- ✗ \$270 billion tax break for wealthy Americans targeted at the top 1% — gives a \$25,900 SALT tax cut to millionaires.
- ✗ Illegal immigrants and felons eligible for upwards of \$45,000/year in government benefits.
- ✗ \$19 million for mussels, butterflies, desert fish, and plants.

DEMOCRATS' FAILURE TO BUDGET:

- ✘ Created broad and sweeping changes to House rules to exempt massive new spending from budgetary enforcement.
- ✘ Nominated Neera Tanden as OMB Director and then withdrew her nomination when a record of personal attacks against members of both parties and managerial failures was exposed.
- ✘ Retroactively advanced a FY21 Budget with half the fiscal year already complete to trigger partisan reconciliation to pass the \$2 trillion Biden Bailout Bill.
- ✘ Recklessly threatened America's seniors with a \$36 billion cut to Medicare next year and then violated the 2010 PAYGO law.
- ✘ Biden's FY22 budget was latest Presidential Budget ever transmitted to Congress.
- ✘ Refused to comply with oversight requests for information regarding hundreds of billions spent through the Biden Bailout Bill.
- ✘ The Biden WH has ignored 35 oversight requests from House Budget Republicans.
- ✘ Failed to mark-up or hold a House vote on the FY22 Budget, simply hiding it in a House Rule, to trigger reconciliation to spend \$5 trillion.
- ✘ House Budget Democrats have refused to hold a single oversight hearing all year.
