A BILL

To strengthen congressional oversight of the Administrative Pay-As-You-Go Act of 2023, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Strengthening Admin-

5 istrative PAYGO Act of 2024" or the "SAP Act of 2024".

6 SEC. 2. CONGRESSIONAL OVERSIGHT OF ADMINISTRATIVE

PAY-AS-YOU-GO ACT OF 2023.

8 (a) WAIVER.—Section 265 of the Administrative9 Pay-As-You-Go Act of 2023 (title III of division B of the

Fiscal Responsibility Act of 2023 (Public Law 118–5)) is
 amended by adding at the end the following:

- 3 "(c) SUBMISSION TO BUDGET COMMITTEES.—The
 4 Director shall submit, to the Committees on the Budget
 5 of the House of Representatives and the Senate—
- 6 "(1) any waiver determination under subsection
 7 (a) and a detailed explanation of why such waiver
 8 was necessary; and
- 9 "(2) an estimate of the budgetary effects of the
 10 covered discretionary administrative action so
 11 waived.".

12 (b) EXEMPTION.—Section 266 of such Act is amend-13 ed to read as follows:

14 "SEC. 266. APPLICATION.

15 "(a) IN GENERAL.—This title shall apply to any ad16 ministrative action that increases direct spending by at
17 least—

18 "(1) \$1,000,000,000 over the 10-year period
19 beginning with the current year; or

20 "(2) \$100,000,000 in any year during such 1021 year period.

"(b) REVIEW.—With respect to any covered discretionary administrative action exempted under subsection
(a), the Director shall submit, to the Committees on the
Budget of the House of Representatives and the Senate

and the Comptroller General, an estimate of the budgetary
 effects of the covered discretionary administrative action
 so exempted.".

4 (c) STATEMENT OF PURPOSE WITH RESPECT TO
5 BUDGET NEUTRALITY.—Section 261 of such Act is
6 amended to read as follows:

7 "SEC. 261. SHORT TITLE; PURPOSE.

8 "(a) SHORT TITLE.—This title may be cited as the9 'Administrative Pay-As-You-Go Act of 2023'.

"(b) PURPOSE.—It is the purpose of this title to establish a budget neutral requirement for discretionary administrative actions of the executive branch that affect direct spending.".

(d) TERMINATION OF SUNSET.—Section 268 of such
Act is hereby repealed (and redesignate sections 269 and
270 as sections 268 and 269, respectively).

17 (e) BUDGET SUBMISSION.—Section 1105(a) of title
18 31, United States Code, is amended by adding at the end
19 the following:

"(40) the number of waiver determinations
under section 265(a) of the Administrative Pay-AsYou-Go Act of 2023 (title III of division B of the
Fiscal Responsibility Act of 2023 (Public Law 118–
5))—

"(A) submitted during the prior fiscal year
 and the first quarter of the current fiscal year;
 and

"(B) expected to be submitted during the second, third and fourth quarters of the current fiscal year and expected to be submitted in the fiscal year for which the budget is submitted.".
